- ☐ Article II Objectives Section 1: Remove "uniformity in playing rules"
- □ Article II Objectives Section 3: Change American Bowling Congress (ABC) and Women's International Bowling Congress (WIBC) to United States Bowling Congress (USBC)
- □ Article III Membership and Organization Section 1: Remove "The Federation shall be a representative, legislative, and executive body for tournaments and functions encompassing all its affiliated membership."
- □ Article III Membership and Organization Section 2/Section 3: Shall read "Nisei League *and/or* Nisei Association
- □ Article IV Membership Eligibility Section 1 Shall read "Nisei League *and/or* Nisei Association", Replace ABC/WIBC with USBC.
- □ Article IV Membership Eligibility Section 2 Shall read "Nisei League and/or Nisei Association"
- □ Article IV Membership Eligibility Section 3 (1) Replace ABC/WIBC with USBC.

 □ Article VI – Appeals and Reinstatements Section 3 – Shall read "Other appeals and requests for reinstatements may be presented by any member and must be submitted through their league and/or association in writing." □ Remove Article VI – Appeals and Reinstatements, Section 4. □ Article VII – Suspensions Section 1: Shall read "Any member who does not abide by the by-laws, rules, and regulation set forth by the Federation may be subject to suspension." □ Article IX – Officers and Committees, Section 2: Replace "cabinet" with "Board of Directors" □ Article IX – Officers and Committees, add a Section 9: "Line Officers and Statistician can approve expenditures up to \$50.00 without Board of Directors approval." □ Article XII – Federation Approved Tournaments Section 1 (1b): Shall read: "Another Federation recognized Nisei League and/or Nisei Association. A list of Federation recognized Nisei League and/or Nisei Association will be published prior to the first Federation tournament of each year. □ Article XII – Federation Approved Tournaments Section 1 (2): Shall read: "A Federation tournament which offers a "team event" must require that at least <i>one</i> (1) of the bowlers on each participating "team" be of Japanese ancestry." □ Article XII – Federation Approved Tournaments Section 1 (3): Replace ABC/WIBC with USBC. □ Article XII – Federation Approved Tournaments Section 3: Replace "entry blanks" with entry forms." □ Louise Utsurogi will send a draft of the By-Laws, which will include all updates and revisions discussed today, to the Board of Directors for further review. □ Everyone was asked to send any comments/suggestions to Louise after reviewing the first draft. □ Louise will compile a <i>final draft</i> to discuss at the next meeting.
